All vaccines recommended by the Advisory Committee on Immunization Practices (ACIP) are covered by MaineCare pharmacy benefit without a member copayment, that includes influenza vaccines. In preparation for the 2024/25 Influenza (Flu) season, please review the MaineCare preferred vaccines listed below which do not require prior authorization (PA).

Influenza vaccines:

- Afluria<sup>®</sup> (Trivalent)
- Fluarix<sup>®</sup> (Trivalent)
- FluLaval<sup>®</sup> (Trivalent)
- Fluzone<sup>®</sup> (Trivalent)

Based on Advisory Committee on Immunization Practices (ACIP) recommendations, the following vaccines are preferred for members  $\geq$  65 years of age:

- Fluad<sup>®</sup> (Trivalent)
- Flublok<sup>®</sup> (Trivalent)
- Fluzone<sup>®</sup> (High-Dose Trivalent)

Additionally, the vaccines listed below are recommended by ACIP and covered as preferred without a member copayment on the MaineCare pharmacy benefit All vaccine products may be subject to age edits based on the vaccine's labeled indication:
